 - (V) Vagrant: a species that occurs less than annually anywhere/anytime in your Big Day's Area (state, county)
 - (R) Rare/Unusual: a species that occurs less than annually along your Big Day route, but is regular in occurrence elsewhere in Washington State
 - (L) Late: a species that occurs regularly along the Big Day route at an earlier season, but which is unexpectedly tardy
 - (E) Early: a species that occurs regularly along the Big Day route at a later season, but which is unexpectedly early
 - (M) Missed: a species that you had over a 95% chance of encountering, but which was inexplicably missed
 - (S) Stake Out: a species that you have "staked out" in advance, either through scouting or the grapevine
- A list with any **Items of Special Interest**, such as: unusual weather conditions, other natural history highlights, significant numbers of a species, unusual personal incidents, etc.
